## **BDA 2019 Travel Raffle**

### Official Rules and Regulations

400 Raffle Tickets will be sold up until January 22nd, 2020 at midnight or sooner, if all tickets are sold prior to this date. Tickets are available for purchase through any BDA board member or staff, at BDA events and online at brunswickdowntown.org. Credit card, Cash or Check (made out to BDA) will be accepted as payment.

The winner will receive a Travel Voucher valued at \$5,000, valid only through use with CRUISE PLANNERS, MAINE. Winner may redeem their voucher towards any vacation package (valued at \$5,000) offered by CRUISE PLANNERS MAINE as they offer various vacation destinations worldwide. Vacation MUST be booked by April 1 2020. However, actual travel can occur any time through March 31, of 2021. This voucher cannot be redeemed for air only and must be used for a vacation package. If a vacation package exceeding \$5,000 is chosen by the winner, the winner is required to pay the price difference at his or her own expense. The prize voucher CAN be transferred to another party PRIOR to booking in the event that the winner is unable to use the travel voucher.

There will be ONE (1) First Prize WINNER selected by random draw at the BDA Annual Meeting in January 2020. Random drawings will be made for Second and Third prize winners on the same date and location. Winners do not need to be present to win. Brunswick Downtown Association will contact the winners according to the contact information provided on the winning tickets.

Prize must be claimed within thirty (30) days of the drawing date. If the prize has not been claimed within those thirty (30) days, the initial winner forfeits the prize and a new winner will be selected by random draw.

**The prize/travel voucher is not redeemable for cash. Raffle tickets are non-refundable.**

CRUISE PLANNERS MAINE will assist the winner with choosing a vacation and with additional complimentary travel planning for chosen vacation.
